

Saraswat Co-operative Bank Ltd. (Scheduled Bank)

Second Addendum to Process Document dated 13TH December 2023

Saraswat Co-operative Bank Limited ('Bank'), has proposed to Sale/Assign Portfolio of NPAs comprising of Corporate and Retail Accounts ('Portfolio') as a Single Lot and has appointed BOB Capital Markets Limited ('BOBCAPS'), for assisting & advising the Bank on the process ('Process Advisor') & matters incidental thereto in connection with the Sale/Assignment. In the said context, Bank and BOBCAPS has uploaded Newspaper Advertisement & Process Document dated 13th December 2023 and Addendum dated 28th December 2023 on their respective website. Post publication of newspaper advertisement and uploading of Process Document/Addendum, Permitted Entities initiated their due diligence, however some of the Permitted Entities informed that they would need further time for completion of due diligence.

Based on requests received from Permitted Entities for extending the timeline, Bank has decided to extend the timelines mentioned in the Process Document and Addendum, accordingly the revised timelines are detailed below:

VDR shall be accessible post submission of required documents only irrespective of the time of submission of EOI. VDR shall be closed for access as per the timelines set above, unless extended at the sole discretion of the Bank.

All the dates mentioned elsewhere in the Newspaper Advertisement & Process Document and Addendum, stands revised as per the above-mentioned timelines. All other terms & conditions of the Process Document shall remain unchanged except to the changes mentioned above.
