**Fourth Addendum to Process Document dated 13<sup>th</sup> December 2023**

Saraswat Co-operative Bank Limited ('Bank'), has proposed to Sale/Assign Portfolio of NPAs comprising of Corporate and Retail Accounts ('Portfolio') as a Single Lot and has appointed BOB Capital Markets Limited ('BOBCAPS'), for assisting & advising the Bank on the process ('Process Advisor') & matters incidental thereto in connection with the Sale/Assignment. In the said context, Bank and BOBCAPS has uploaded Newspaper Advertisement & Process Document dated 13<sup>th</sup> December 2023 and Addendums dated 28<sup>th</sup> December 2023, 10<sup>th</sup> January 2024 and 17<sup>th</sup> January 2024 on their respective website. Post publication of newspaper advertisement and uploading of Process Document/Addendums, Permitted Entities initiated their due diligence, however some of the Permitted Entities informed that they would need further time for completion of due diligence considering the ensuing holidays on account of Republic Day and weekend thereafter.

Based on requests received from Permitted Entities for extending the timeline, considering the ensuing holidays on account of Republic Day and weekend thereafter, Bank has decided to extend the timelines mentioned in the Process Document and Addendum, as a last & the final extension and there would not be any further extension in the timelines. Accordingly, the revised timelines are detailed below:

All the dates mentioned elsewhere in the Newspaper Advertisement & Process Document and Addendums, stands revised as per the above-mentioned timelines. All other terms & conditions of the Process Document shall remain unchanged except to the changes mentioned above.
